Cr. Application has been filed on behalf of the accused petitioner namely Golo Khalkho in connection with Complaint Case No. 621/2020 registered against him u/s. 181 of Motor Vehicles Act. On being pressed the accused petitioner is taken into custody and the said petition is taken up for hearing. It has been submitted by the learned counsel appearing on behalf of the accused petitioner that a complaint case u/s. 181 of Motor Vehicles Act is pending against him in the learned Court. It is further submitted that the accused petitioner does not want to proceed and contest this case. It is also submitted that he wants to plead guilty in the alleged case and hence, the learned counsel prays that this petition may be allowed. Heard the learned counsel and perused the case record. It manifests that Officer-in-charge of Bhandra P.S., Lohardaga had submitted the prosecution report dated 17.12.2020 and the cognizance of the offence u/s. 181 of the Motor Vehicles Act has already been taken vide order dated 17.12.2020. The said case is at the stage of appearance of the above named accused petitioner. Today the accused person has voluntarily surrendered before the Court. Substance of accusation u/s.

181 of Motor Vehicles Act has been read over and explained to him in Hindi to which he pleaded guilty. Further, the statement of said accused petitioner was recorded u/s. 313 of Cr.P.C. wherein he has again pleaded guilty.

Hence, considering the above facts and circumstances of the case, the miscellaneous criminal application / plead guilty petition filed on behalf of accused petitioner stands allowed. Further, the accused petitioner namely Umesh Prasad is held guilty for the offence u/s. 181 of Motor Vehicles Act. Accordingly, the accused petitioner named above is sentenced to deposit fine of Rs. 5,000/- (Five Thousand) for the offence u/s. 181 of the Motor Vehicles Act. Let the fine cheque be issued. The Misc. Cr. Application No. 1888/2022 is hereby disposed of.
