Bail application U/s 438 of Cr.P.C. for the grant of anticipatory bail in DDR no.27 dated 29.06.2020, under section 324, 326, 506, 34 IPC in FIR no.229 dated 25.06.2020 under section 324, 323 506, 34 of IPC and section 326 of IPC has been enhanced later on police station Sadar, Tarn Taran.

ORDER

The instant application preferred U/s 438 of Cr.P.C. for the grant of anticipatory bail presented before me being Duty Judge. Let notice to the Addl.PP for the State be issued for 04.08.2020. Record be also called for the date fixed.

2) Learned counsel for the applicant submitted that a false case has been filed by the complainant with totally false and frivolous allegations and no such offence whatsoever is made out against the applicant from the bare perusal of the allegations of the complaint. The complainant has made a concocted story just to implicate the present applicant in the present case. Nothing is to be recovered from the present

applicant and there is no need of custodial interrogation of the applicant. The applicant is ready to join the proceedings. With these submissions, he requested for according interim bail to the applicant till the final decision of this bail application.

3) Heard. At this juncture, without going into the merits of the instant case, the aforesaid applicant-accused namely Gurpreet Singh, hereby, directed to cause appearance before the SHO/IO of the PS Sadar, Tarn Taran and in case he do so, he will be admitted to ***interim bail*** till 04.08.2020 on his furnishing the bail bonds in the sum of ₹ 50,000/- with one surety in the like sum of the applicant to the satisfaction of IO/SHO of PS Sadar, Tarn Taran with the direction that the applicant will not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him/her from disclosing such facts to the Court or to any police officer and the applicant will not leave the country without the prior permission of the Court.
