

Sessions case (POCSO) no. 159/2022

Order No. 10 dated 26.06.2024:-

Record is put up today by a put up petition filed by Ld. Lawyer from LADCS, Jalpaiguri on behalf of accused Paran Mallick @ Mallik alongwith downloaded copy of order of the Hon'ble Circuit Bench of Calcutta High Court at Jalpaiguri passed in CRM (DB) No.228 of 2024 under Sec. 439 Cr.P.C. dated 20.05.2024 in connection with Maynaguri P.S. case No.490/2022 dated 12.12.2022 u/s 376(2)(n)/506 of the IPC and Sec. 6 of the POCSO Act and also filed a verification certificate of Ld. Advocate Kishan Sah of LADCS, Jalpaiguri confirming the genuineness of the order of the Hon'ble High Court, praying for releasing of the accused.

Heard both sides.

Perused the record and the order of the Hon'ble Circuit Bench of Calcutta High Court at Jalpaiguri passed in connection with CRM (DB) No.228 of 2024 under Sec. 439 Cr.P.C. dated 20.05.2024 wherein the Hon'ble High Court was pleased to pass the order in the manner that;

*“5. Accordingly, we direct that the petitioner shall be released on bail upon furnishing a bond of **Rs.10,000/- with two registered sureties of like amount each**, to the satisfaction of the learned Judge, Special Court under POCSO Act-cum-learned Additional Sessions Judge, 2nd Court , Jalpaiguri, subject to condition that petitioner shall appear before the trial court on every date of hearing until further orders and shall not intimidate witnesses or tamper with evidence in any manner whatsoever.”*

Let the orders of the Hon'ble High Court be kept with the record.

In view of the order of the Hon'ble Circuit Bench of Calcutta High Court at Jalpaiguri passed in connection with CRM (DB) No.228 of 2024 under Sec. 439 Cr.P.C. dated 20.05.2024 the accused, **Paran Mallick @ Mallik** shall be released on bail on furnishing bond as enumerated in the order of the Hon'ble Court. The accused/petitioner is directed to comply with the conditions as enumerated in the order of the Hon'ble High Court.

Since, the bail bond register is maintained by the office of the Chief Judicial Magistrate, Jalpaiguri the accused is directed to furnish the bail bond in the office of the Ld. C.J.M., Jalpaiguri.

Let a copy of this order be sent to the court of Ld. C.J.M., Jalpaiguri for information and taking necessary steps.
