Sole accused person namely Sanjay Tudu is produced from J/C. Ld.Counsel for the accused person appointed from L.A.D.C.S is also present.Ld.Public Prosecutor is present and filed draft charge, which be kept with the record.

Today is fixed for consideration of Charge. Accordingly the record is taken up. Perused the materials available on record along with the C.D. It appears that tthere are sufficient materials to frame charge for commission of offence under section 103(1) of the B.N.S against the accused person.

3) As such, Charge for the commission of offence **under section 103(1) B.N.S is framed against the accused person** during which the contents of the accusation are read over and explained to the accused person individually in vernacular to which he pleaded **NOT GUILTY** and claimed to be tried in this case.

4) Accordingly, let the case be posted for prosecution evidence.

5) At this stage, Ld.Advocate for the accused has preferred an application u/s.254(3) B.N.S.S. Keeping in view the possibility of disclosure of defence case, *petition is allowed*. Cross examination of C.S.W-1 shall be deferred till recording of evidence of C.S.W-2 is concluded.

6) To 20/07/2026 for C.S.W.No.1 & 2

7) Prosecution is directed to issue summon.

8) Accused person must remain present.
