**ORDER**

**1) The accused is hereby convicted for the offence under Section 144 (a) and 147 of the Railways Act, 1989 and is sentenced to pay a fine of Rs. 1000/- for for contravention of section 144 (a) and Rs.500/- for contravention of section 147, (Collectively Rs. 1500/-) (In words Rs. One thousand five hundred only) and in default to undergo simple imprisonment for 3 days.**

**2) Seized muddemal be disposed of as per rules.**
