ORDERS

The complainant has filed this complaint under section 200 of Cr.P.C., for the offense under section 138 of Negotiable Instrument Act against accused person.

Complainant's sworn statement recorded by way of affidavit and examined as Pw1 and documents are produced such as Original cheque drawn at SBI Bank, Chikkanayakanahalli branch, on 17.08.2022 said to have been issued by the accused in favor of complainant, Endorsements dated 26.08.2022 and 27.08.2022, legal notice dated 02.09.2022 issued by complainant through his counsel demanding accused to pay cheque amount well within time as contemplated under provision 138 of N.I. Act, postal receipt and acknowledgement having served on accused.

On perusal of the complaint and documents placed on record, it discloses that, the complainant made prima-facie case against accused for the offence punishable under section 138 of N.I. Act by complying the essential condition that have to required to be fulfilled as contemplated under the provision of sub-clause (a) to (c) of section 138 of the said act before initiation of the case.

Hence, on considering the material fact and document, cognizance is taken against accused for the offence punishable under section 138 of Negotiable Instrument Act.

Office is directed to register the criminal case in the concerned register.

Issue summons to the accused by RPAD, if PF and cover is enclosed.
