Chief Examination:

Presently I am working as Administrator in M/s.Shree Tech Engineering, Neyveli. I have completed B.E(EEE) in the year 2017. I am married to Mr.Sreedharan, he have completed B.Tech(Mechanical Engineering). I have preferred complaint dated 06.01.2022 addressed to Chief Vigilance Officer, Neyveli Lignite Corporation India Limited(NLCIL) in regard to cheating committed by Joseph Peter Antony and Antony for securing a job in Railway Department for myself and my husband.

During January 2021 Joseph Peter Antony and Antony approached my husband to secure a job at Railway Department and also he advised me to get job at Railway Department. Antony is my husband's friend and Joseph Peter Antony is Antony's

father. Since Antony is childhood friend of my husband, we had faith in him. Me and my husband went to my husband's friend marriage function in Neyveli. There we met Joseph Peter Antony and he told us that he is trying a job for his son Antony and two or three relatives and other Antony's friend Dinesh in Railway and told to secure a job for my husband and myself in Railway Department. Further he told for securing job for me and my husband as Junior Engineer in Railway Department, he asked Rs.20 Lakhs each. I told to him that we will discuss and inform you later. I asked how he will get job in Railway Department for us, he told that his relatives working at Railway Department and Antony's uncle Wilson is a politician and with his reference we will get job for you and your husband in Railway Department. After that me and my husband discussed about this offer. Since we were not able to arrange such huge amount we informed Antony and he suggested post of Commercial Clerk in Railway for myself and Junior Engineer for my husband and he told to pay total Rs.10 Lakhs for Commercial Clerk and Rs.20 Lakhs for Junior Engineer post. We agreed to get job in Railway Department through Antony. We informed Antony and Joseph Peter Antony about this. After that Joseph Peter Antony informed us to follow his son Antony for further instructions. After that Antony asked to my husband to send educational qualification documents like degree certificates, 10th and 12th marksheets. Through whatsapp my husband shared his educational qualification documents to Antony's mobile. He informed once you are fit for post Junior Engineer in Railway within two days we have to pay initial amount of Rs.8 Lakhs for Junior Engineer and Rs.5 Lakhs for Commercial Clerk. Antony after perusing the documents sent by my husband confirmed that he is fit for the post of Junior Engineer as per his qualification and told us to pay initial amount within two days for securing job. We informed our father-in-law Mr.Murugadoss about the job offer. He agreed and told that I had money which he has taken as loan for our marriage, and I will give the money for securing job.

After that my husband informed Joseph Peter Antony and Antony about the arrangement of money and asked about the details of account for payment. Joseph

Peter Antony informed that since he is working and to avoid income tax problem he asked to contact his son Antony for making payment. Then Antony shared two bank account numbers/details to my husband through Whatsapp and informed to send Rs.4 lakhs to each account numbers.
