Perused the application and say filed thereon. Also heard the Ld.Advocate for accused and Ld.APP for the State at length.

2] According to prosecution, the present accused assisted accused No. 1 in demanding and accepting a bribe from the informant for performing an official duty.

3] The record reveals the investigation to the extent of present accused is complete. Also the panchanamas are prepared in presence of panch witnesses and amount has been allegedly recovered. Apparently, there is no need for further detention of accused. in these circumstances, considering the facts, it is in the interest of justice to release the accused on bail with condition to co-operate in the investigation and provide voice samples, hence, the order :-

ORDER

1. The application is allowed.
2. The accused **Firoj Papalal Vijapure** in **Crime No.357 of 2026** registered at **Police Station, Shirol** for the offences punishable under **Secs. 7,7(A), 12 of Prevention of Corruption Act** be released on

bail on furnishing PR. & S.B. of Rs.50,000/- with one or more sureties of the like amount.

3. The accused shall provide provide voice samples as and when required.
4. The accused to cooperate in the further investigation, if any.
