ORDER

23-02-2026. Complainant has filed his attendance through his advocate, who has filed a complaint petition against seven accused persons namely, *Ashok Saw, Lalit Kumar, Dayanand Saw, Dharmshila Devi, Samudri Devi, Sapna Kumari and Mausam Kumari.*

Perused the case record, from perusal of the same it appears that the complainant has been examined on S.A. and during the course of inquiry total two inquiry witnesses namely, EW-1 *Ajay Kumar Sah* and EW-2 *Kranti Devi* have been examined.

Perused the complaint petition, S.A. of complainant and statement of three inquiry witnesses. From the above-said perusal, in brief, the grievance of the complainant is, as alleged, that I have filed this case against *Ashok Saw, Dayanand Saw, Ashok Saw, Lalit Kumar Saw, Dharmshila Devi, Samudri Devi, Sapna Kumari, and Mausam Kumari.* The incident occurred on 26.04.2025, at 7 P.M. I returned home from work. All the accused persons arrived, each carrying a spade and a stick, and *Sapna* had a knife. The accused persons asked where my father was, and I told them he hadn't returned from work. My father arrived just then. *Ashok Saw* grabbed my father's *hydrocele* and began beating him. *Ashok Saw* said, "The previous case has cost me 30,000 rupees, and I have to pay bail for another person, so I'll have to pay 50,000 rupees." When my elder sister-in-law, *Kranti Devi*, came to rescue me, *Dayanand Saw* stripped her naked and pulled her *mangalsutra*, worth 100,000 rupees, from her neck. The other accused persons assaulted me, my father, and my elder brother, *Abhay Saw*. People came upon the commotion. All the accused persons said they would not testify, otherwise they would do the same to you. I have filed a lawsuit regarding this incident. Further perusal reveals that the complainant and his inquiry witnesses have supported the complaint story. So, considering the facts and circumstances of the case and materials available on record, this Court finds that a prima-facie case is made out only for the offense **u/s. 115(2), 352 of the B.N.S.** only against Accused namely ***Ashok Saw, Lalit Kumar, Dayanand Saw, Dharmshila Devi, Samudri Devi, Sapna Kumari and Mausam Kumari.***

The complainant is directed to file essential requisites within seven days for issue summon to the above-named accused persons for facing trial.
