

Succession 43 of 2022

Case of the petitioners, in brief, is that one Arun Das, son of Lt. Dwarika Nath Das, resident of Vill- Khaschak Monosakhali, P.O. Khalisakhali, P.S. Basanti, Dist- South 24 Parganas, died on 26.05.2022 at SSKM Hospital Bhowanipore, Kolkata- 700020, leaving behind his widow Lila Das, one son namely Rajib Das and married daughter Itika Das (petitioners) as his legal heirs.

To the best of the knowledge of the petitioners, the deceased Arun Das did not execute any Will nor any application has been filed before any Court of competent jurisdiction for granting of probate of any will or for Letters of Administration to the estate of deceased.

Under these circumstances, the petitioners pray for succession certificate authorizing them to realise and collect debts, interest and effects of deceased Arun Das, as mentioned in the Schedule of this petition.

Accordingly, it is,

Ordered

Petitioners namely Rajib Chandra Das and others are hereby authorized to realize and collect debts, interest and effects of deceased Arun Das, specifically mentioned in the schedule of the application as per law of inheritance applicable, if any.

Let a succession certificate be issued in favour of the petitioners within two months from passing of this order.

Clerk in charge is directed to issue succession certificate after observing all the legal formalities.
