In the present application, the applicant Safoora Zargar seeks permission to travel to her native place i.e. Sri Nagar from 14.08.2026 to 18.08.2026 for attending two marriage ceremonies in near relations.

It is submitted that two of her cousins namely Yavar and Nayraeen are going to marry from 16.08.2026 to 18.08.2026 and 25.08.2026 to 26.08.2026 respectively. Further, the applicant has plan to travel to Sri Nagar by air and got her tickets booked. It is further submitted that earlier also the applicant has been allowed by the court on a number of times to travel to Kashmir and Sri Nagar and never misused the liberty.

The Ld. SPP submits that the applicant may not be allowed to travel as her absence may hamper the proceedings of the court.

Considering the fact that earlier, whenever the applicant was allowed to travel to her home town and other places in Kashmir, she never misused the liberty and attended the proceedings of the case through VC and lawyer, and the fact that she wishes to attend the marriage ceremonies of her cousins, the application is allowed.

The applicant is accordingly permitted to travel to Shri Nagar from 14.08.2026 to 28.08.2026.

During this period, the applicant may join the court proceedings through VC or through counsel.

As prayed, copy of this order be given dasti to the Ld. Counsel for applicant/accused.
