

Sessions case (POCSO) No.159 of 2022

Order No.02 dt. 14.12.2022

The record is taken up for hearing of petition filed by the I.O praying for shown arrest of accused Paran Mallick, who is stated to be arrested in connection with Maynaguri PS case no. 468/22 dated 26.11.2022 u/s 25(1)(a)/27(2) of Arms Act r/w Sec 4/9B of the Explosives Act.

I.O. of the case is present in the court along with C.D.

Ld. Spl P.P. is also present who submitted that the case is registered against the accused Paran Mallick but was not apprehended as yet. During the investigation the I.O. came to learn that the accused person is detaining at Jalpaiguri Central Correctional Home in connection with aforesaid case. He further submitted that arrest of the accused is necessary for the purpose of proper investigation of the case and prayed for allowing prayer of I.O.

Perused the petition filed by the I.O. along with C.D.

It is found that accused Paran Mallick, S/o- Dulu Mallick @ Dupu of Begunbari, PS Dhupguri, Dist Jalpaiguri is F.I.R. named accused in this case. It also appears that he has been in custody in connection with Maynaguri PS case no. 468/22 dated 26.11.2022 u/s 25(1)(a)/27(2) of Arms Act r/w Sec 4/9B of the Explosives Act.

On perusal of the record and the C.D. of the case in hand, I found that the accused is F.I.R. named and his custody for the purpose of proper investigation is necessary.

Considering the above facts and circumstances, the prayer of I.O. for shown arrest of accused Paran Mallick is considered and allowed.

Issue production warrant against Paran Mallick, S/o- Dulu Mallick @ Dupu of Begunbari, PS Dhupguri, Dist Jalpaiguri.

Accordingly Superintendent of Jalpaiguri Central Correctional Home is directed to produce the accused Paran Mallick, S/o- Dulu Mallick @ Dupu of Begunbari, PS Dhupguri, Dist Jalpaiguri who is detained in the Correctional Home in connection with Maynaguri PS case no. 468/22 dated 26.11.2022 u/s 25(1)(a)/27(2) of Arms Act r/w Sec 4/9B of the Explosives Act.

Fix **21.12.2022** for production of accused Paran Mallick before this court.

Let a copy of this order along with production warrant be sent to the Superintendent of Jalpaiguri Central Correctional Home through I.O. of the case for information and compliance.
