

**Sessions case (POCSO) no. 8/2022**

**J.O code- WB00732**

**Order No. 14 dated 6.03.2024:-**

Record is put up today by a put up petition filed on behalf of accused Ratan Bhattacharjee alongwith downloaded copy of order of the Hon'ble Circuit Bench of Calcutta High Court at Jalpaiguri passed in CRM (DB) No.46 of 2024 under Sec. 439 Cr.P.C. dated 05.03.2024 in connection with Jalpaiguri Women P.S. case No.04/2022 dated 12.01.2022 u/s 6 of the POCSO Act and also filed a verification certificate of Ld. Advocate Debi Sarkar confirming the genuineness of the order of the Hon'ble High Court, praying for releasing of the accused/petitioner.

Heard both sides.

Perused the record and the order of the Hon'ble Circuit Bench of Calcutta High Court at Jalpaiguri passed in connection with CRM (DB) No.46 of 2024 under Sec. 439 Cr.P.C. dated 05.03.2024 wherein the Hon'ble High Court was pleased to pass the order in the manner that;

*"We accordingly direct that the petitioner shall be released on bail upon furnishing a bond of **Rs.10,000/- (Rupees ten thousand only)** with two sureties of like amount each, one of whom must be local, to the satisfaction of the learned Additional Sessions Judge, 2<sup>nd</sup> Court, Jalpaiguri. The petitioner shall not induce witnesses or influence them or tamper with the evidence. The petitioner shall also make himself available for the trial as and when the petitioner is required and shall also not leave the jurisdiction of the concerned police station without leave of the concerned authorities."*

Let the orders of the Hon'ble High Court be kept with the record.

In view of the order of the Hon'ble Circuit Bench of Calcutta High Court at Jalpaiguri passed in connection with CRM (DB) No.46 of 2024 under Sec. 439 Cr.P.C. dated 05.03.2024 the accused/petitioner, **Ratan Bhattacharjee** shall be released on bail on furnishing bond as enumerated in the order of the Hon'ble Court. The accused/petitioner is directed to comply with the conditions as enumerated in the order of the Hon'ble High Court.

Since, the bail bond register is maintained by the office of the Chief Judicial Magistrate, Jalpaiguri the accused/petitioner is directed to furnish the bail bond in the office of the Ld. C.J.M., Jalpaiguri.

Let a copy of this order be sent to the court of Ld. C.J.M., Jalpaiguri for information and taking necessary steps.
