During hearing Ld defence Lawyer submits that the accused is a tribal person and he is innocent and has been falsely implicated in this case. Accordingly, he prays for bail of accused on that score.

Ld Special P P submits that the accused is a tribal person and one Civil Suit is pending between the parties. Charge sheet has already been submitted in this case. He thus, leaves the matter upon the judicial discretion of the court for necessary order.

I have perused all the materials on record and heard the submission of Ld Lawyers for both sides. It appears from the record that the accused is a Tribal person and one civil case is pending between the parties and today the accused has voluntarily surrendered before the court. Considering the act of voluntary surrender of the accused, I have no reason to detain the accused behind the bar any further. Accordingly, the prayer for bail of accused is allowed.

Accordingly, accused, **Ganapati Narjari @ Gonopati Narjinary** may find bail bond of Rs. **2,000/-** with one registered surety of like amount, subject to the satisfaction of Ld CJM, Alipurduar on condition to appear before the court on each and every date fixed.

If on bail, to-date (**20.11.2024**) for appearance & further order.
