ORDER BELOW EXH. 3
PLEAD GUILTY UNDER SECTION 252 OF THE CODE OF CRI. PRO.
(Delivered on 12/11/2022)

Today the accused appeared in the matter. I read over and explained particulars of the offence to the accused. The accused pleaded guilt voluntarily. He filed pursis Exh. 2 to that effect. He has pleaded guilt voluntarily, hence I have to accept it and convict on his plea. However, the accused submitted that he is poor and only earning member of his family. Therefore, he prayed for lenient view.

Taking into consideration the nature of the offence and the submission made by the accused and reason that, I am of the opinion that the following sentence will meet the ends of justice. Hence, I pass following order.

ORDER

1. Accused Balu Sukhadeo Khandare, is convicted for the offence punishable under Section 12 (A) of Bombay Prevention of Gambling Act under Section 252 of the Code of Criminal Procedure and sentenced to imprisonment till rising of the court and to pay fine of amount of **Rs. 300/- (Rupees Three hundred)** in default to suffer simple imprisonment for 2 (two) days.
2. The muddemal i. e. cash amount of Rs. 920/- be credited to the Government and remaining muddemal being worthless be destroyed after the appeal period is over
3. Proceeding hereby closed.
