Tagar @ Tabor Ghosh....accd-Vs- State of W.B.

Order No.2 dt.09.03.26.

This is an application U/S 483 BNSS filed by accused/petitioner **Tagar @ Tabor Ghosh**, the resident of Alipurduar Paschim Jitpur, Bakultala, P.S. Alipurduar, Dist. Alipurduar, in connection with Kalchini P.S. Case No.18/2026 dt. 15.02.26, u/s 109/85 BNS, corresponding to G.R. Case No.307/2026.

Learned Advocate appearing for the accused/petitioner submits that the accused/petitioner has not moved any bail application for and on behalf of the accused before the Hon'ble High Court or the Hon'ble Supreme Court and no such application is pending or disposed of before the Hon'ble High Court or the Hon'ble Supreme Court.

Learned Advocate for the accused/petitioner Tagar @ Tabor Ghosh submitted that he has been falsely implicated in the present case and he is in J/C for more than 14 days, hence prays for bail on any stringent condition.

Learned Public Prosecutor, on the other hand, submitted that police has already submitted charge sheet on 06.03.26 in the instant case and the section levelled against the accused is Magistrate triable i.e. Section 85/115(2) of BNS.

Having heard the submission of Learned Advocate for both sides and upon considering the fact that charge sheet has already been submitted under Magistrate triable offence. Therefore, considering the above fact, the detention of the accused in the J/C for the purpose of investigation is not at all warranted. Hence, prayer for bail is **allowed**.

The accused/petitioner **Tagar @ Tabor Ghosh** may find bail of Rs.3,000/- with two sureties of Rs.1,500/- each, subject to the satisfaction of Learned CJM, Alipurduar.
