Accused persons namely 1) **Nurul Islam**, 2) **Golam Masun**, 3) **Sahajad Almamun**, 4) **Omeda Begam**, 5) **Safia Khatun**, 6) **Nur Amin**, 7) **Md. Mintu**, 8) **Golam Rabbani**, 9) **Juel Rabbani**, 10) **Sariful Islam**, 11) **Jakir Hossain**, 12) **Golam Mustafa (Togor)** and 13) **Sabir Alam** on Court bail are present by filing hazirah.

Ld. P.P. In-Charge Smt. Gopa Kundu is present by filing hazirah.

The case record is taken for framing of charge.

Perused the materials relied upon by the prosecution as available in the CD and in the case record. Ld. PP in-charge submits that materials in hand clearly suggest that there are sufficient materials to frame charge for commission of offence **U/S 448/427/436/506/34 of Indian Penal Code, 1860** against the above named accused persons. Ld. Advocate for the accused persons has submitted that his clients are innocent although at the same time he has conceded that charge-sheet contains few materials against them, which is, in his version, manufactured for the case.

Heard both sides and considered.

I find sufficient materials and accordingly, the charge is framed **U/S 448/427/436/506/34 of Indian Penal Code, 1860 against accused persons** and the content of charge to the effect that *‘on 01.06.2023 at about 12.00-13.00 hrs. at Paschim Khairbari under Madarihat PS, in furtherance of common intention committed criminal house trespass by entering in the house of the defacto complainant and cut down betel nut trees and on the same day at about 22.00 – 22.30 hrs. caused destruction by setting fire by pouring kerosene oil on the dwelling house of the defacto complainant and also threatened the defacto complainant with dire consequences’*, is read over and explained to the accused persons in Bengali to which they pleaded not guilty by saying each of them “Nirdosh” and claimed to be tried.

Issue summon upon the witness at once.

Prosecution to take step.
