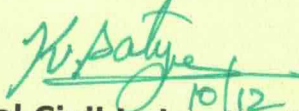
JUDGMENT

This petition filed on behalf of the Petitioner U/sec.125 of Cr.P.C. The Respondent to pay Rs.50,000/- per month to the 1st Petitioner for her food, clothing, medicines, shelter, medical expenses and other expenses etc., and to pay Rs.30,000/- per month to the Petitioner No.2 for her food, clothing, other expenses etc., i.e., total Rs.80,000/-(Rupees Eighty Thousand only) per month towards their maintenance, Rs.3,000/- towards costs of the petition.

Petitioner absent. No representation. Enquiry not commenced, despite giving ample opportunity Passing conditional orders and even on imposing costs. Costs also not paid. Under the circumstances this court is of considered view that the Petitioner is not interested in Proceeding with the case. Hence the case is **dismissed for non Prosecution.**

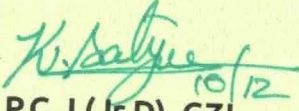
