JUDGMENT

The accused is present before the Court. He pleaded guilty vide application (Exh.2). I explained him the consequences of his pleading guilty & disqualification which he may have to suffer. Still, he wants to plead guilt. The alleged offence punishable under Section 185 of the Motor Vehicle Act for the first offence is punishable with imprisonment upto six months or with fine of Rs. 10,000/-, or with both. There is no contention of the prosecution that it is the subsequent or second offence of the accused. Accused, himself submitted that it is his first offence. He proved for lienery. I ascertained that the plea made by the accused is voluntarily made by him. As accused voluntarily pleaded guilty, his plea is accepted. Accordingly, I pass the following order-

ORDER

1. The accused Shrikant Maruti Wadkar is convicted under section 252 of Criminal Procedure Code for the offence punishable under section 185 of the Motor Vehicles Act.
2. He is sentenced to pay fine of Rs.10,000/- (Rs. Ten Thousand only). In default of payment of fine, he shall suffer simple imprisonment for one month.
