The instant Criminal Misc Case is arisen out of the bail application filed u/s 482 BNSS by the applicant/petitioners namely, 1) Enamul Hoque @ Miya Enamul Hak, 2) Shahajahan Alam @ Sahajahan Ali, 3) Mainul Hoque @ Haque, 4) Maksedul Hoque @ Moksedul Haque, 5) Bapi Roy @ Bappi Roy, 6) Barun Roy, 7) Murgidul Hoque @ Musidul Haque, 8) Tapan Roy, 9) Shishir Roy, 10) Manab Hoque @ Manir Haque all the resident of Deomali, P.O. Khagenhat, P.S. Falakata, Dist. Alipurduar, in connection with G.R. Case No.920/2026, arising out of Falakata P.S Case No.279/2026 dated 05.05.26, u/s 329(4)/326(g)/326(f)/117(2)/74/303(2)/3(5) of BNS.

Heard Ld. Advocate for the accused/petitioners and submitted that these accused persons are falsely implicated due to political rivalry. Moreover, one of the accused arrested in this case, has been granted bail. Their custody is not required. Hence their prayer may be allowed.

Ld. Advocate for the accused/petitioners further submitted that no bail application has been filed or pending before the higher Court.

Heard Learned P.P who raised objection.

Perused the CD and materials therein.

Considering the alleged nature of offence and materials with CD I do not think it is a fit case to grant anticipatory bail to the accused/petitioners. Accordingly, their prayer for anticipatory bail is **rejected**.

The bail application is thus disposed of.

Return the LCR and CD.
