Today is fixed for appearance & charge.

Sole accused person, namely, Sujit Das @ Sujit on CB is present by filing hazira.

Ld P P in-charge Mr Rajib Sutradhar files hazira. Ld Advocate for the accused person is also present.

Now the case record is taken up for consideration of charge.

Perused the materials relied upon by the prosecution in the CD and in the case record. Ld. PP in-charge submits that materials in hand clearly suggest that there are sufficient materials to frame charge for commission of offence u/s. 304 of I P C against the above named accused person. Ld. Advocate for the accused person raised no objection, rather conceded the submission made by the Ld. PP in-charge.

Heard both sides and considered. Let charge be framed u/s. 304 of I P C against the accused person, namely, Sujit Das @ Sujit and same was read over and explained [more vividly ascribed in the relevant charge form appended in the case record] to the accused person in Bengali to which he pleaded not guilty by saying "Nirdosh" and claimed to be tried.

For ends of justice following schedule is fixed for evidence.

To **21.07.2023** for evidence of CSW No. 1, Mr Diabandhu Paul, S/O, Late Balaram Paul of Kayakhata, PS- Samuktala and District- Alipurduar,

Issue summons upon the C S witness at once.

Prosecution to take step.

I O is directed to produce all the witnesses on the date fixed for trial and to remain present during the course of trial as per verdict of Hon'ble Apex Court. He is further directed to produce alamat, if any, on the date fixed.

Let copy of order be sent to I O, Jakir Hossain, S I of police through R O, Alipurduar for his information and compliance.

Let another copy of this order be sent to OC, Samuktala P S with a direction to look into the matter personally so that summons upon the witnesses be served within the date fixed and also directed to produce alamat before the court on the date fixed
