The instant Criminal Misc Case is arisen out of the bail application filed u/s 482 BNSS by the applicant/petitioners namely, **1) Sapna Barman @ Swapna Barman, 2) Ramesh Barman,** both the resident of village Chapatali, P.O. Banchukamari, P.S. & Dist. Alipurduar, **3) Krishna Roy,** resident of Purba Satali, P.S. Kalchini, Dist. Alipurduar, **4) Santi Das @ Shanti Barman Das,** **5) Bisnupada Das @ Bishnupada Das,** both the resident of Pakritala, P.O. Tapshikhata, P.S. & Dist. Alipurduar, in connection with G.R. Case No.1372/2026, arising out of Alipurduar P.S Case No.284/2026 dated 14.06.26, u/s 126(2)/329(3)/115(2)/117(2)/324(4)/109/79/351(2)/3(5) of BNS.

Heard Ld. Advocate for the accused/petitioners and submitted that the complainant and the accused persons are related to each other. There are civil dispute among them regarding the landed property and one civil case is pending before the Court. The complainant accordingly lodged the false complaint against the accused persons with ulterior motive to harass them and their prayer may be allowed.

Ld. Advocate for the accused/petitioners further submitted that no bail application has been filed or pending before any higher forum.

Heard Learned P.P.

Perused the CD. It appears that there is civil case pending between the parties. There are civil dispute among the parties. I find no any material from CD to require the detention of the accused persons in this case for the sake of investigation. Considering as such their prayer for anticipatory bail is **allowed**.

Accordingly, in the event of arrest, the petitioners namely, **1) Sapna Barman @ Swapna Barman, 2) Ramesh Barman, 3) Krishna Roy, 4) Santi Das @ Shanti Barman Das, 5) Bisnupada Das @ Bishnupada Das,** may find bail of **Rs.1,000/- each** with one surety of like amount, subject to the satisfaction of the arresting officer and also subject to the fulfillment of the condition as required u/s 482(2) of BNSS.

The bail application is thus disposed of. Return the LCR and CD.
