

**NDPS 145 of 2025**

**Order No. 36, dated 09.03.2026**

Today is fixed for framing of charge in respect of accused Phurba Lama @ Kami.

The accused Phurba Lama @ Kami is produced from JC.

Ld. P.P. in charge and Ld. Advocate for the accused are present.

Record is taken up for framing of charge.

Ld., P.P. in-charge opens the case by stating over the offence made out against the accused Phurba Lama @ Kami and submits there are sufficient ground to presume that the accused have committed offence punishable under section 21 (c)/29 of NDPS Act.

Accordingly, charge is framed, read over and explained to the accused to which he pleaded not guilty and claimed to be tried in open court.

Today is fixed for production of the accused Phurba Lama @ Kami.

One bail application is filed for the accused Phurba Lama @ Kami.

Ld. P.P. in charge and Ld. Advocate for the accused are present.

It is submitted by the Ld advocate for the accused, that the accused has been falsely implicated in this case. It is also submitted that the accused has detained in custody for a considerable period. It is further submitted that the accused has hearth within the jurisdiction of this court and will not abscond if enlarged on bail.

Ld PP in charge does not raise vehement objection to the bail of the accused but submits that condition should be imposed upon the accused to ensure his presence before this court.

Heard the submission of both sides. Considered.

On perusing the record it appears that the allegation has been made out against the accused that he was found to possess contraband narcotic substance. It also appears that investigation is complete and culminated into filing of charge sheet bearing No.200/2024 dated 31.10.2024. The charge has been framed against the accused Phurba Lama @ Kami and the accused has been in custody for




considerable period. Now it appears that there is not opportunity of imminent conclusion of trial. 2, the prolonged detention of the accused will not subserve the cause of justice.

Considering all the above aspect, let the accused Phurba Lama @ Kami be enlarged on bail of Rs. 5,000/- with two registered sureties of Rs. 2,500/- each subject to satisfaction of the Ld Chief Judicial Magistrate, Alipurduar and on the condition to be present before the court on each date fixed.

To date 07.04.2026 for appearance if on bail.
