(Delivered on 11-04-2023)**

ORDER

Case advanced. A2 (A8 in original case) filed petition through counsel stating that he is pleading guilty. Petition allowed. Particulars of offence read over and explained through counsel to which he pleaded guilty. Plea accepted and A2 (A8 in original case) is found guilty and convicted for the commission of offences punishable U/s 188, 269, 270 IPC, 118(e) of KP Act and sec.4(2)(b), 5 of KEDO 2020. In the result, he is sentenced to fine of Rs.500/- for the offence punishable U/s 188 IPC, in default of payment of fine, simple imprisonment for 3 days, sentenced to fine of Rs.500/- for the offence punishable U/s 269 in default of payment of fine, simple

imprisonment for 3days, sentenced to fine of Rs.500/- for offence punishable U/s 270 IPC, in default of payment of fine, simple imprisonment sentenced to fine of Rs.1000/- for offence punishable U/s 118(e) of Kp Act,in default of payment of fine, simple imprisonment for six days and sentenced to fine of Rs.500/- for offence punishable U/s 4(2)(b), 5 KEDO 2020, i in default of payment of fine, simple imprisonment for 3 days. The case against A1 (A3 in original case) is split up as CC 40/2023
