Accused **Imran Ali** is physically present in Court on call.

Today is fixed for consideration of charge. It appears that copy has already been delivered to the accused.

Ld. Addl P.P. is ready for framing of charge. The matter for consideration of charge of the above accused is taken up for hearing in presence of both sides.

Heard both sides. Perused the materials on record and case diary.

On perusal of the statement of the witnesses, medical report and statement of VG during investigation vis a vis the other materials on record, I find that a prima facie case has been made out against the above named accused **under Section 4 of POCSO Act.**

Accordingly, charge is framed against the above accused **under Section 4 of POCSO Act.** The contents of the charge is read over and explained to the accused in his own language in presence of his Ld. Advocate to which he pleaded not guilty by saying 'ami nirdosh' and claimed to be tried.

The charge framed in separate sheets be kept with the record.

Ld. Advocate for the accused files a bail petition. Which is kept with the record.

Fix 08.07.2026 for evidence of VG and complainant. Issue summons accordingly.
