Accused persons, namely, 1) Sahadeb Mukherjee and 2) Haradhan Mukherjee are produced from C.H and they are taken into custody and remanded to J.C till next date.

Today is fixed for hearing of the bail petitions dt.09.05.2024 and dt.12.06.2024 and for consideration of charge.

The record is taken up first for consideration of charge.

It appears that C.S has been submitted against the accused persons after conclusion of investigation initiated on the basis of written complaint lodged by the father of the minor victim girl that accused persons of this case wrongfully restrained her minor victim girl in a jungle under P.S Arsha and committed criminal intimidation and threatened the V.G not to disclose the incident of rape committed by accused Sahadeb Mukherjee upon the V.G. Later the incident was also videographed and transmitted it in electronic form and the V.G was used in pornographic purposes. The materials available on record are sufficient to prove and harbour the charge that may be framed against the accused persons.

So charge is framed against the accused persons, namely, **Sahadeb Mukherjee U/s.341/506 IPC and U/s.6 of the POCSO Act** and against accused person, namely, **Haradhan Mukherjee U/s.341/506 IPC, U/s.12 of the POCSO Act and U/s.67B(a)/14(1) of the I.T.Act.**

The charge so framed is read over and explained to the accused persons in Bengali to which they pleaded not guilty and claimed to be tried.

Charge framed against the accused persons in separate sheets are kept with the record.

Strictly comply U/s.207 Cr. P.C and R.91A of Cr. R.O, if any.

Dates for trial are fixed as under :

To 17.9.2024, 18.9.2024 and 19.09.2024 for evidence from prosecution side.

Prosecution is directed to produce the witnesses and alamats, if any, on the dates fixed. Issue summons accordingly.

To 17.09.2024 for production of accused persons from J.C.

C.D be returned.

Defacto complainant of this case is absent today. So both the bail petitions dt.09.05.2024 and dt.12.06.2024 could not be heard today.

To 05.07.2024 for hearing of both the bail petitions dt.09.05.2024 and dt.12.06.2024 in presence of the defacto complainant.
