hereby charge you -

Manna @ Ajinul Islam

As follows -

Firstly, That you, on 16.08.2016 at around 12:10 PM, at Tshemila while the complainant was returning after collection of money from customers, voluntarily caused hurt by means of sharp knife with a view to extort money from the complainant (victim) and thus you thereby committed an offence punishable under **Section 323** of Indian Penal Code and within the cognizance of this Court.

Secondly, That you on the same date, place and time, voluntarily caused voluntarily hurt to the complainant by means of sharp knife with such intention and under such circumstances that if by that act you had caused the death of said complainant, you would have been guilty of murder and you thereby committed an offence punishable under **Section 307** of Indian Penal Code and within the cognizance of this Court.

And I hereby direct that you be tried by this Court on the said charge.

Charge is read over and explained to the accused persons in presence of his Ld. Advocate who plead not guilty by uttering “ami nirdosh” and claims to be tried.
