Today is fixed for production of the accused persons from J.C. and for hearing of the bail petition dt.12.02.2024 for accused Sahadeb Mukherjee and also hearing of the bail petition dt.16.02.2024 for accused Haradhan Mukherjee.

Said bail petitions are taken up for hearing.

Perused the materials on record as well as in the C.D. Heard both sides. Considered.

At the time of hearing, Ld. Advocates for said accused persons have prayed for bail for said accused persons and have submitted that this accused persons have been falsely implicated in this case and that they may be enlarged on bail on any condition.

Ld. Spl. P.P has submitted that in the instant case the statement of the victim girl has been recorded U/s.164 Cr.P.C and that the investigation is in the initial stage and that at this stage the accused persons should not be enlarged on bail.

On perusal of the materials in the C.D, it appears that the alleged offence is **U/s.341 IPC & U/s.4,6,11 of the POCSO Act** and that during investigation the statement of the victim girl has been recorded u/s.164 Cr.P.C. Perused the same. Also perused other materials in the C.D.

Considering the nature of the alleged offence, the statement of the victim girl made U/s.164 Cr.P.C and other incriminating materials in the C.D against the present accused

Both said accused persons are hereby remanded to J.C till 01.03.2024.
