CHARGES WITH THREE HEADS

I, Nilanjana Chatterjee,
Additional Session Judge, 1st Court, Berhampore, Murshidabad,
hereby charge you (1) Biplab Sarkar;
(2) Kuntalika Sarkar;
(3) Naresh Sarkar; and
(4) Biren Sarkar @ Biran Sarkar

as follows:-

Firstly:- That you Biplab Sarkar married the victim in the year 2019 and since then you being the husband and the other accused persons (Sl. Nos. 2 to 4) being the -in laws of the victim in furtherance of common intention had subjected her to immense physical and mental torture and thereby you all committed the offence of cruelty punishable under **Section 498A/34 of the Indian Penal Court** and within the cognizance of the Court of Session;

Secondly:- That you, Biren Sarkar being the father-in-law of the victim outraged her modesty by hurling obscene abusive words at her and thereby committed an offence punishable under **Section 354 of the Indian Penal Court** and within the cognizance of the court of Session;

Thirdly :- That you all in furtherance of common intention physically assaulted the victim to such a manner while she was 3 months pregnant that she suffered miscarriage thereby you all committed an offence punishable under **Section 313/34 of the Indian Penal Court** and within the cognizance of the court of Session;

And you all having pleaded not guilty to the charge, I hereby direct that you all be tried by this court on the said charge.
