That you accused on 21.1.26 at 11:45 hours at मो. 29 Mumbai, you drove vehicle bearing no. MH- 47BL-9965 on a public way in negligent or rash manner so as to endanger human life and to be likely to cause hurt or injury to others, and thereby committed an offence punishable under section 281 of BNS and within my cognizance.

Secondly, on above mentioned date, time and place, you accused drove/ride vehicle in rash or negligent manner so as to endanger human life or the personal safety of others and thereby committed an offence punishable under section 125 BNS and within the cognizance of this Court.

Thirdly, on above mentioned date, time and place, you accused found driving the above mentioned vehicle which was not in conformity with any indication given by mandatory traffic sign and not in conformity with the driving regulations made by the Central Government and also not comply with all the directions given to you by any police officer for the time being engaged in the regulation of traffic in any public place and thereby contravened Section 119 of the MV Act and thereby committed an offence punishable under Section 177 of the Motor Vehicle Act and within my cognizance.

Plea of Accused:

Q.1: Have you received copies of the charge-sheet and documents filed with it?

Ans. Yes.

Q.2: Do you understand allegations made against you, which now read over to you?

Ans. Yes.

Q.3: Do you plead guilty ?

Ans. Yes.

ORDER BELOW EXH. 1

Today, the accused appeared before the Court. He is charge-sheeted for the offences punishable U/secs. 281, 125 of BNS r/w 119, 177 M.V. Act

The particulars of the charge are read over and explained to the accused. He pleaded guilty to the charge. I have verified that his plea is voluntary. Hence, I accept the same. He prayed for leniency on the ground that he has to take care of his family members and prayed to impose minimum fine. His plea being voluntary. I accept it.

Perused the record and proceeding. It is seen that the informant was injured due to rash and negligent driving of the accused. Considering the submissions and the nature of act committed by the accused, in my opinion, following sentence will meet ends of justice. Hence, I proceed to pass following order.

ORDER

Accused मो. बजरंग इस्लाम शाही is hereby convicted for the offences punishable U/secs. 281, 125 of BNS, r/w 119, 177 M.V. Act.

The accused is sentenced till rising the court and to pay fine of Rs.1,000/- (one thousand). In default of fine of payment, he is to suffer simple imprisonment for 15 (fifteen) days in respect of offence punishable U/sec. 281 of BNS.

The accused is sentenced to pay fine of Rs.2500/- (Rs. Two Thousand). In default of fine of payment, he is to suffer simple imprisonment for () days/months in respect of offence punishable U/sec. 125 of BNS.

The accused is further convicted vide Section 275 of BNSS for the offence punishable under Section 177 of the Motor Vehicle Act and are sentence to pay a fine of Rs.1000/- (Rs. One Thousand), and in default to undergo simple imprisonment for Three days.

In default of payment of fine, sentence of imprisonment to run consecutively.

The accused is to surrender to his bail bonds.

Muddemat property i.e. vehicle be returned to or if already returned, be retained by the registered owner.

Cash security, if any, be refunded to the accused.
