Perused the application for bail and the case record.

It appears that warrant of arrest were issued vide order dated 26.09.2025 when none appeared on repeated calls and today these accused petitioners voluntarily surrendered before this Court. I am of the view that another opportunity should be given to these accused petitioners for appearance before this Court by allowing the instant application for bail. Accordingly, the prayer for bail stands **allowed**.

The accused petitioners, namely, **Whab Ansari @ Ohab Ansari** and **Suman Mandal @ Sumon Sk** may be enlarged on bail on furnishing bond of **Rs. 5,000/-** with two sureties of **Rs. 2,500/- each**, **other than previous sureties**, subject to the satisfaction of the Ld. C.J.M Murshidabad.

Let a copy of this order be sent to the Ld. C.J.M. Murshidabad for information and taking necessary action.
