**CHARGES WITH THREE HEADS**  
[NO.XXVII(II) SCHEDULE V, ACT V, 1898]  
(Sections 221,222,223, Code of Criminal Procedure)

I, Shri Ajay Kumar Singh  
Additional Sessions Judge,  
3<sup>rd</sup> Court, Murshidabad  
Berhampore, West Bengal.  
hereby charge you –

**1) Samim Rejjak 2) Manoyara Bibi 3) Sajan Sk @ Monayem Hossain and 4) Dilrupa Khatun @ Dilruba** as follows:-

**Firstly**, that you in furtherance of common intention since after marriage and on 04.12.2018 at about 7:30 p.m. at your house at village Mirjapur Mallikpara, under PS- Beldanga being the husband and relatives of Lalbanu Bibi subjected her to cruelty by physically and mentally torturing her and accordingly committed offence u/s. 498A/34 of the IPC and within (3) the cognizance of this Court.

**Secondly**, that you on the said date, time and place, in furtherance of your common intention attempted to commit murder of Lalbanu Bibi by throttling her and that you thereby committed an offence punishable under section 307/34 of the Indian Penal Code, and within the cognizance of this Court.

**Thirdly**, that you since marriage of Lalbanu Bibi with Samim Rejjak demanded and took dowry from the parents of the de- facto complainant and that you all thereby committed an offence punishable u/s.3/4 D.P.Act and within the cognizance of this court.

And I hereby direct that you be tried on the said charge.

Substance of the charge of the offence punishable under the aforesaid section so framed against accused persons as mentioned here-in- above is read over and explained to them in Bengali to which they pleaded not guilty and claimed to be tried.
