3) Heard. At this juncture, without going into the merits of the instant case, the aforesaid applicants-accused are hereby, directed to appearance before the SHO/I.O of police station Goindwal Sahib within 7 days and in case they do so, they shall be admitted to interim bail till 2.9.2019 to the satisfaction of Investigating Officer/SHO, with the direction that the applicants shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him/her from disclosing such facts to the Court or to any police officer and the applicants shall not leave the country without the prior permission of the Court.
