The record is put up today on the strength of a put up petition filed on behalf of the accused person, namely, Roni Sheikh @ Rani Sheikh.

The accused person, namely, Roni Sheikh @ Rani Sheikh surrenders voluntarily before this Court. He is taken into custody and remanded to J/C.

Ld. P.P.-in-Charge is present. So does the Ld. Defence Counsel.

Ld. Defence Counsel by filing a web copy of the order of the Hon'ble High Court, Calcutta dated 11.08.2025 coupled with an affidavit and a vokalatnama, submits that the accused person has been granted anticipatory bail U/S 482 of the Bharatiya Suraksha Nagarik Sanhita by the Hon'ble High Court, Calcutta passed in C.R.M.(A) No. 2291 of 2025 and he prays for necessary order for furnishing bail bonds.

Perused the copy of order of the Hon'ble High Court, passed in C.R.M.(A) No. 2291 of 2025 dated 11.08.2025.

On perusal of the order of the Hon'ble High Court, passed in C.R.M.(A) No. 2291 of 2025 dated 11.08.2025, I find that the Hon'ble High Court has been pleased enough to grant anticipatory bail U/S 482 of BNSS, 2023 in favour of the accused person by passing the following order :-

“In the event of arrest, the petitioner shall be released on bail upon furnishing a bond of Rs. 10,000/- with two sureties of like amount each, one of whom must be local, to the satisfaction of the Arresting Officer and also be subject to the conditions as laid down under Section 438(2) of the Code of Criminal Procedure, 1973 corresponding to Section 482(2) of the BNSS, 2023 and on further conditions that the petitioner shall not threaten or intimidate witnesses, shall attend the jurisdictional Court regularly and shall surrender before the jurisdictional Court and pray for bail within four weeks from this date.”

In view thereof, the accused person is permitted to furnish bonds in terms of the order of the Hon'ble High Court, Calcutta.
