The case record is placed before this Court today as per Put-up petition filed on behalf of the accused persons Chinmoy Ghosh and Sanjoy Ghosh.

One surrender petition along with a petition, praying for bail on behalf of accused persons namely **Chinmoy Ghosh** and **Sanjoy Ghosh** and one Vakalatnama of the Ld. Counsel are filed.

Let these be kept with the record.

Accused **Chinmoy Ghosh** and **Sanjoy Ghosh** surrender this day by petition.

Accused **Chinmoy Ghosh** and **Sanjoy Ghosh** with a lapping baby are taken into custody and remanded to J/C.

Recall W.A. at once.

The application filed on behalf of accused **Chinmoy Ghosh** and **Sanjoy Ghosh**, praying for bail is taken up for hearing, on being moved by the Ld. Counsel for the accused persons.

Ld. P.P. for the State is present.

Heard both sides.

Perused the application for bail and the case record.

It appears that previously the accused persons were on bail, but subsequently, being absent before this Court, warrant of arrest was issued against them as per order dated 11.06.2026.

Considering all, as the accused petitioners voluntarily surrender before this Court and for the first time they made themselves absent from attending the proceeding of this Court and thus, I am of the view that the appearance can be ensured during trial if bail is granted to the accused persons with registered surety on following terms and conditions.

Accordingly, the prayer for bail stands **allowed**.

The accused petitioners, namely, **Chinmoy Ghosh** and **Sanjoy Ghosh** may be enlarged on bail on furnishing bond of **Rs. 3,000/- each** with two sureties of **Rs.1,500/- each**, **other than previous sureties**, subject to the satisfaction of the Ld. C.J.M, Murshidabad.

Let a copy of this order be sent to the Ld. C.J.M. Murshidabad for information and taking necessary action.

Though the case is relating to crime against women but the same is transferred to the Court of Ld. Additional Sessions Judge, 3rd Fast Track Court, Berhampore, Murshidabad for disposal in view of the Resolution No.2512-A dated 02.07.2020 of Hon'ble High Court, Calcutta.

Fix **17.08.2026** for appearance of the accused persons, if on bail, i.d. production before the Transferee Court.
