ORDER.

Raman alias Rawan Deep Kaur and Komal Kaur (*accused-applicants*) has filed instant bail application *under Section 482 BNSS (Bhartiya Nagrik Suraksha Sanhita)* on the ground that, they are innocent, have been falsely implicated in this case being daughters in law, just to put pressure upon other co-accused/non-applicants. Moreover, alleged allegations leveled by complainant against applicants/accused for dragging and snatching of gold chain are altogether false. As per medico legal report neither any abrasion, contusion or reddishness has been found at person of complainant/injured. Co-accused Manjit Singh is already in custody. Now, the police officials of **Police Station Kulgarhi, Ferozepur**, are conducting raids in the house of the accused-applicants. They are ready to join the investigation, if in that event IO/SHO/arresting officer be directed that on doing so, they be released on bail. (*Application is duly supported with affidavit*).

2. Upon notice, *Sh.Amandeep Prinja, learned Additional Public Prosecutor*, for the State duly assisted by *Sh. Arshdeep Singh Randhawa, Adv.* counsel for complainant appeared. No reply to the application has been filed but hotly contested the same. It is submitted that since there are specific allegations leveled that

applicants/accused being members of the unlawful assembly assailed injuries on the person of complainant/injured with other co-accused/non-applicant Manjit Singh (already arrested), therefore, opposed prayer.

3. As per report of Ahlmad as well as Filing Branch, no bail application filed by applicants/accused is pending in the Hon'ble High Court. Copy of report downloaded from the website of Hon'ble Punjab and Haryana High Court is attached. However, bail application of co-accused Parminder Kaur alias Parvinder Kaur was dismissed by this court vide order dated 07.01.2025.

4. **Police record** requisitioned, produced by **Head Constable Gurdarshan Singh No.870/FZR** posted at **police station Kulgarhi, District Ferozepur** who has suffered statement to the effect :

- (i) That **this is first bail application of applicant/accused** and no other bail application of applicants/accused is pending before any court of law.
- (ii) That as per **MLR of Jagir Singh** (injured), injuries attributed to Manjit Singh and Pirtam Singh (co-accused/non-applicant) with reverse side of Kappa collectively, same was declared as '**dangerous to life**' vide report dated **16.10.2024**.
- (iii) That as per **MLR of Krishna** (injured) total four injuries are shown. **Injuries No.1,3 and 4** were

kept under observation whereas, injury **No.2** was declared as '**simple in nature**'.

- (iv) That as per MLR of Harjinder Singh (injured) one injury attributed to Pirtam Singh (co-accused/non-applicant) with reverse side of Kappa, same was kept under observation.
- (v) That co-accused Manjit Singh is in custody since 17.12.2024.
- (vi) That offence under section 238 of BNS was added on 17.12.2024.
- (vi) That no other offence has been added or deleted in the FIR.

5. Criminal law was set into motion on the basis of statement suffered by **Krishna** wife of *Harjinder Singh (complainant)* that house of Pritam Singh, who lives with his sons namely Bohar Singh alias Akash; Jasvir alias Gora and Manjit Singh alias Kala and other family members is situated in front of their house, who are alcoholic and used to cause nuisance and hurl abuses to the residents of the area after consuming alcohol. On 12.10.2024, in the evening, they all under influence of alcohol, came in front of gate of their house and by calling names of their family members, started exhorting lalkaras, hurled abuses. Matter was reported to Ex.Sarpanch; Sarpanch Chanan Singh; Member Tarsem Singh and Member Panchayat Joginder Singh. Request was also made to Pritam Singh not to do so. On **15.10.2024**,

at about 8:30 PM, when she alongwith Harjinder Singh(husband); Jashanpreet Singh (son) and Ramanpreet Kaur (daughter) after taking meal were sitting in lobby, they heard noise from outside. While going out, after opening main door of house, saw **Pritam Singh** armed with **‘Kappa’**; **Manjit Singh** armed with **‘Kappa’**; **Jasbir Singh** armed with **‘iron rod’**; **Parminder Kaur**; **Raman and Komal** all armed with **‘sticks’** alongwith 4-5 unidentified persons who were with muffled faces armed with rods and baseball bats were standing there. When, she opened door, then all the above stated persons forcibly entered into house. Pritam Singh and Manjit Singh alias Kalu raised lalkara to *‘teach a lesson for making complaint before Panchayat and not to spare them’*. On hearing noise, her husband Harjinder Singh also came to courtyard. **Manjit Singh** gave **reverse side of kappa blow**, with **intention to kill**, same hit at **back side of head of Harjinder Singh** (husband). When she came forward to rescue him, **Pritam Singh** gave **reverse side of Kappa blow**, with **intention to kill**, same hit above her left ear. **Manjit Singh** alias **Kala** gave **reverse side of kappa blow**, with **intention to kill**, same hit at her **cheek towards left side of face**. **Parminder Kaur** also gave **stick blow**, same hit at right side of her **head**. **Jasvir Singh** alias **Gora** also gave **iron rod blow**, with **intention to kill**, same hit at back side of her **head**.

Raman wife of Jasvir and **Komal** dragged her from hair and gave beatings. *They both also snatched gold chain from her neck.* All assailants after entering into their rooms, damaged refrigerator and also ransacked household articles. Their noise attracted Suhwinder Singh (brother in law) and Jagir Singh(Ex.Member Panchayat) and when they intervened, **Manjit Singh alias Kalu** gave **kappa blow, with intention to kill, same hit on head of Jagir Singh.** Thereafter, **Pritam Singh** also gave **kappa blow, with intention to kill, same hit above right eye of Jagir Singh.** Blood was profusely oozing from the person of Jagir Singh. Many persons attracted to spot. Upon this, all the assailants by hurling abuses, managed to fled away from the spot alongwith their respective weapons. They were shifted to Civil Hospital, Ferozepur by Sukhwinder Singh where subjected to medico legal examination and thereafter, shifted to GGS Medical College and Hospital, Faridkot. On 16.10.2024, she (complainant) was got admitted at Baghi Hospital, Ferozepur. **Motive :** *‘all the accused under influence of alcohol, used to hurl abuses and caused nuisance. As matter was reported to Panchayat and they were admonished, thus accused were nursing grudge and assailed injuries’.*

*As per MLR of **Harjinder Singh**, one (01) injury i.e. on*

head, with reverse side of Kappa, attributed to Pritam Singh, same was kept under observation.

As per MLR of Jagir Singh, two (02) collective injuries i.e. above right eye and near to head, with reverse side of Kappa, attributed to Manjit Singh and Pritam Singh, same was declared as “Dangerous to life” vide opinion dated 16.10.2024.

As per MLR of Krishna, four (04) injuries were observed, which are as follows:-

- 1. Above left ear, with reverse side of Kappa, attributed to Pritam Singh, same was kept under observation.*
- 2. Right side of head, with stick, attributed to Parminder Kaur, same was kept under observation.*
- 3. Left side of head, with iron rod, attributed to Jasbir Singh, same was kept under observation.*
- 4. Kick blows, attributed to Raman and Komal Kaur.*

Instant case under sections 109, 304, 333, 351(2), 115(2), 324, 191(3), 190 of BNS, was got registered.

6. After having considering rival submissions put forth by counsel for both the parties and perusal of the original file reveals that, there are only alleged allegations of dragging as well as snatching of

gold chain against the applicants/accused and as per medico legal report of complainant/injured neither any abrasion, contusion or reddishness has been found. Moreover, Manjit Singh(main accused/non-applicant) is already in custody. Thus, without commenting upon the merits of the bail application, it seems that, there is enough space for investigation from the point of view of the applicants/accused. Moreover, after applicants/accused join the investigation, clouds of dust surrounding the prosecution case, would become clear and, it would lead the case to logical conclusion and further, in order to conduct effective investigation, **Raman alias Rawan Deep Kaur and Komal Kaur (accused-applicants)** are **allowed** to join investigation **within three days**, and on their doing so, they shall be released on **interim anticipatory bail** to the satisfaction of Investigating Officer/Arresting Officer/SHO concerned, subject to the compliance of the following conditions:-

1. That the applicants shall join the investigation as and when required by the police.
2. That the applicants shall not directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the court or to any Police Officer.

3. That the applicants shall not leave India without prior permission of the court.

Copy of this order be sent to the concerned quarters for compliance. Record be produced on **27.01.2025**. However, these observation of mine shall have no effect on the merits of the case.
