Today is fixed for consideration of charge. .

Eight(8) accused persons namely, i) **Md. Biplab Biswas @ Abdullah**, ii) **Md. Abbas Ali**, iii) **Nur Islam Mondal @ Mijanur**, iv) **Sajibur Islam**, v) **Minarul Sk**, vi) **Sadik @ Suman @ Rahim @ Tariqul Islam**, vii) **Md. Shab Sekh @ Shad Radi & viii) Mustakim Mondal** are produced from the J/C through Video Conference.

Learned Counsel, namely, Mr. Chittarajan Das for the accused Biplab Biswas @ Abdullah, Ld. Counsel Mr. Amit Biswas on behalf of the accused Nur Islam Mondal @ Mijanur, Ld. Counsel Mr. Debraj Mukherjee on behalf of the accused Sadik @ Suman @ Rahim @ Tariqul Islam, Ld. Counsel Mr. Musaraf Hossain for the accused persons, namely, Minarul Sk, Sajibur Islam and Md. Abbas Ali, Ld. Counsel Mr Parijat Roy with Nargis Tanzim for the accused Mustakim Mondal and Ld. Counsel Md. Abu Hasan for the accused Md. Shab Sekh @ Shad Radi are present.

Learned Special Public Prosecutor for the STF West Bengal, Mr. Subedi Sanyal is present and files a draft charge. According to him, charge may be framed against all the above named accused persons u/s 113(3), 113(3), 113(5), 113(6) and 61(2) of the BNS along with u/s 17, 18, 18A, 18B, 19, 20, 38, 39 and 40 of the UAPA and against accused Tarikul Islam @ Sadik @ Suman @ Raihan Sk u/s 14(c) of the Foreigners Act and against accused Md. Shab Sekh @ Sad Sk @ Shad Radi u/s 14(c) Foreigners Act and u/s 12(1)(b), 12(1A)(a) & 12(3) of the Passport Act.

Ld. Counsels for the accused persons prays for time of hearing of on the point of consideration of charge.

Heard. Considered. The prayer for time is allowed.

A petition has been filed on behalf of the accused Biplab Biswas praying for necessary direction for necessary medical treatment of the accused Biplab Biswas.

Copy served.

Ld. Special for the STF West Bengal raises strong objection as to the reason and cause assigned for the alleged injury.

It is seen from the petition itself that the alleged injury was caused during initial stage of investigation due to brutal police torture. The accused was arrested in the month of February, 2025 and now, it is December, 2025.

However, the Superintendent, Berhampore Central Correctional Home is directed to secure medical treatment of the accused Md.Biplab Biswas, if required and to submit report on the next date fixed.
