Today is fixed for production of the accused persons, hearing of the bail petition filed on behalf of accused Minarul Sheikh and hearing on the point of charge.

Eight (08) accused persons namely, i) **Md. Biplab Biswas @ Abdullah**, ii) **Md. Abbas Ali**, iii) **Nur Islam Mondal @ Mijanur**, iv) **Sajibur Islam**, v) **Minarul Sk**, vi) **Sadik @ Suman @ Rahim @ Tariqul Islam**, vii) **Md. Shab Sekh @ Shad Radi** & viii) **Mustakim Mondal** are produced from the J/C through Video Conference.

Learned Counsel, namely, Mr. Chittarajan Das for the accused Biplab Biswas @ Abdullah, Ld. Counsel Mr. Amit Biswas on behalf of the accused Nur Islam Mondal @ Mijanur, Ld. Counsel Mr. Debraj Mukherjee on behalf of the accused Sadik @ Suman @ Rahim @ Tariqul Islam, Ld. Counsel Mr. Musaraf Hossain for the accused persons, namely, Minarul Sk, Sajibur Islam and Md. Abbas Ali, Ld. Counsel Mr. Parijat Roy with Nargis Tanzim for the accused Mustakim Mondal and Ld. Counsel Md. Abu Hasan for the accused Md. Shab Sekh @ Shad Radi are present.

Learned Special Public Prosecutor for the STF West Bengal, Mr. Subedi Sanyal is present.

Heard Ld. Counsels on the point of consideration of charge.

Ld. Counsel Mr. Debraj Mukherjee argued on behalf of the accused Sadik @ Suman @ Rahim @ Tariqul Islam. Thereafter, learned counsel, namely, Mr. Chittarajan Das for the accused Biplab Biswas @ Abdullah filed a petition praying for adjournment of this case till disposal of Criminal Revision Case No. 41/2025.

Heard learned counsel.

Both the cases were fixed today. Heard both the parties.

It is decided that this case fixed for hearing on the point of charge, and revisional application will be heard today itself and order will be passed in this case simultaneously with the final order in the revisional application. Hence, time petition is rejected.

Heard, learned counsel, namely, Mr. Chittarajan Das on behalf of accused Biplab Biswas @ Abdullah, Ld. Counsel Mr. Amit Biswas on behalf of the accused Nur Islam Mondal @ Mijanur.

Ld. Counsel Mr. Parijat Roy, Anowar Hossain and other counsels on behalf of accused Mustakim Mondal, Md. Shab Sekh @ Shad Radi, Minarul Sk, Sajibur Islam and Md. Abbas Ali are present and Ld. Counsel Mr. Parijat Roy argued on behalf of accused Mustakim Mondal, Md. Shab Sekh @ Shad Radi, Minarul Sk, Sajibur Islam and Md. Abbas Ali.

It is apt to mention that on 02.02.2026 Ld. Counsel Mr. Amit Biswas filed a petition U/S 250 of BNSS, praying for discharge. As already mentioned that he has been heard on that point in respect of accused Nur Islam Mondal @ Mijanur.

Learned Special Public Prosecutor for the STF West Bengal, Mr. Subedi Sanyal is similarly heard.

Fix **07.07.2026** for production of the accused persons and order in respect of consideration of charge after the order in the revisional application.

Now, bail petition dated 11.05.2026 filed on behalf of accused Minarul Sk is taken up for hearing.

Learned counsel candidly submits that bail petition on behalf of this accused has been rejected by Hon'ble High Court.

In view of the same and in view of the previous rejection on the basis of material against the accused, his prayer for bail is rejected.

Thus, bail petition dated 11.05.2026 is disposed of.
