Order No. 07 dated 19.06.2024

All the accused persons namely Kamrul Sk, Saharul Sk, Jahanara Bibi, Chandmala Bibi, Lajmon Bibi, Okhila Bibi on bail are present.

Ld. PP in-charge is present.

The case record is taken up for consideration of charge.

Ld. Defence Counsel is also present.

Ld. PP in-charge has opened the prosecution case by stating the facts of the case as well as by describing the commission of the offence committed u/s 325/448/307/34 of IPC by the accused persons namely Jahanara Bibi, Chandmala Bibi, Lajmon Bibi, Okhila Bibi and the commission of offence committed u/s 325/448/307/354/34 of IPC by the main accused persons namely Kamrul Sk, Saharul Sk as well as by describing their involvement in the commission of the offence as brought against the accused persons and stating by what evidence they proposed to prove the guilt.

Perused the documents available on record.

Heard the submissions of both sides.

Considered.

The materials available before the court and on being perused the same, court finds prima facie material u/s 325/448/307/34 of IPC against the accused Jahanara Bibi, Chandmala Bibi, Lajmon Bibi, Okhila Bibi and prima facie materials u/s 325/448/307/354/34 of IPC against the accused persons namely Kamrul Sk, Saharul Sk available for framing of charge against them. Accordingly, charge u/s 325/448/307/34 of IPC is framed against the above named accused persons namely Jahanara Bibi, Chandmala Bibi, Lajmon Bibi, Okhila Bibi and in prescribed form and the same is kept with the record and similarly the charges u/s 325/448/307/354/34 of IPC is framed against Kamrul Sk, Saharul Sk in prescribed and the same is kept with the record as well.

The contents of the charge u/s 325/448/307/354/34 of IPC are read over and explained in Bengali to the above named accused Kamrul Sk, Saharul Sk, to which they plead not guilty by saying each "Ami Nordos" and each claims to be tried and the contents of the charges u/s 325/448/307/34 of IPC are read over and explained in Bengali to the each accused persons namely Jahanara Bibi, Chandmala Bibi, Lajmon Bibi, Okhila Bibi and to which they pleaded not guilty by saying each "Ami Nordos" and each claims to be tried.

To **01.08.2024** for evidence of CSW 1 & 2.

To **02.08.2024** for evidence of CSW 3 & 4.

To **03.08.2024** for evidence of CSW 5 & rest.

Issue summons upon the CS witnesses.

Ld. PP in-charge to take steps accordingly.

Accused persons on bail as before.
