The case record is put up by petition.

Accused Achhiya Bibi @ Achhiya Bewa surrenders before this Court today by filing surrender petition.

She is taken into custody and remanded to JC.

Recall the two WAs issued against accused Achhiya Bibi @ Achhiya Bewa vide orders dated 02.03.2023 and 24.12.2024.

A bail petition filed on behalf of the accused petitioner which is taken up for hearing in presence of Ld. PP and Ld. defence counsel.

Heard both sides. Considered. Perused the materials available in the case record.

It appears from the record that previously the petitioner was enlarged on bail and since she misused the liberty, WA was issued against her on 02.03.2023. Thereafter, on 24.12.2024, she voluntarily surrendered before this court and she was given in the charge of the Ld. Counsel for the accused and subsequently, she was granted bail. However, before submitting the bail bonds, this accused had left the Court. Accordingly, the order of bail granted by this Court vide order No. 17 dated 24.12.2024 was canceled and fresh WA was issued against this accused/petitioner.

Considering the entire facts and circumstances and having considered the materials on record and taking into consideration that the accused person was previously on bail, I am inclined to give her an opportunity to amend herself and hence, the prayer for bail is **allowed**, i.d. to JC.

Accordingly, accused petitioner Achhiya Bibi @ Achhiya Bewa may find bail of Rs. **14,000/-** with two sureties of **Rs. 7,000/-** each, other than previous sureties, subject to satisfaction of Ld. CJM, Murshidabad, i.d. to JC.

Let a copy of this order be sent to Ld. Chief Judicial Magistrate, Murshidabad for his kind information.
