

CHARGE WITH THREE HEADS

[No. XXVIII (II), SCHEDULE V, ACT V, 1898]
(Sections 221, 222, 223 Code of Criminal Procedure)

I, Smt Manjusri Mondal, Additional Sessions Judge, 1st Court, Murshidabad
hereby charge you as follows : -

1. Milon Ghosh, S/O. Lt.Madhusudan Ghosh.

Firstly – That on 15.06.18 at about 12.30 am (midnight) you trespassed in the house of the complainant Sumitra Halder, W/O. Ranjan Halder of Krishnamati Madhyapara village under Berhampore P.S within Dist. Murshidabad, and you thereby committed an offence punishable under **Section 448 of the Indian Penal Code** within the cognizance of the Court of Sessions.

Secondly – That on 15.06.18 at about 12.30 am (midnight) in the house of the complainant Sumitra Halder, W/O. Ranjan Halder of Krishnamati Madhyapara village under Berhampore P.S within Dist. Murshidabad you attempted to commit rape on the complainant Sumitra Halder and you thereby committed an offence punishable under **Section 376/511 of the Indian Penal Code** within the cognizance of the Court of Sessions.

Thirdly – That you on 15.06.18 at about 12.30 am (midnight) armed with sharp cutting weapon committed mischief by ransacking the house and thereby causing loss and damaged to the complainant's property and hereby committed an offence punishable under **Section 427 of the IPC** and within cognizance of the Court of Sessions.

Fourthly – That you on 15.06.18 at about 12.30 am (midnight) committed criminal intimidation by threatening the complainant Sumitra Halder with injury to her person and property with intent to cause alarm to the said Sumitra Halder and thereby you committed an offence punishable under **Section 506 of the Indian Penal Code** within the cognizance of the Court of Sessions.

I do hereby direct that you be tried on the same charge by this Court.

The contents of the charge under **Section 448/376/511/506 of the Indian Penal Code** is read over and explained to the accused person in Bengali language to which he pleaded not guilty and claimed to be tried by saying 'ami nirdosh'.
