Order No. 22 dated 14.08.2024

The case record is fixed for appearance of accused persons on C/B and appearance of IO of this case with relevant documents as per previous order dt. 05.03.2024.

The accused Saidul Sk and Selim Sk on CB are present by filing hazira.

Ld. Advocate for the accused persons and Ld. PP in-Charge are also present.

One compliance report has been forwarded by SI Dipak Halder, O/C Doulatabad P/S in terms of order No. 20 dt. 05.03.2024.

Ld. PP in-Charge has submitted that when the charge sheet of the instant case was filed by the IO of this case, the number of accused persons charge sheeted were six namely, 1) Saidul Sk, 2) Selim Sk, 3) Monirul Sk, 4) Bikash Sk, 5) Anarul Sk and 6) Yunus Ali Molla.

Relying upon the report submitted by the O.C., Doulatabad P.S., he further has contended that an inadvertent error regarding the name of the accused Bikash Sk S/o. Saidul Sk and Anarul Sk S/o. Saidul Sk was in the charge sheet submitted by the IO. In this connection, he has further submitted that the accused Bikash Sk S/o. Saidul Sk and the accused Anarul Sk is the same person which was rectified by the order of Ld. CJM, Murshidabad vide order dt. 21.08.2018 and accordingly, the column No. 11-A and 12(4) of the C/S No. 150 of 2017 dt. 23.09.2017 was rectified.

Perused the compliance report filed by the OC, Doulatabad P.S in this regard and from the compliance report submitted by the O.C., Doulatabad P.S. it is revealed that Anarul Sk S/o. Saidul Sk and Bikash Sk. S/o. Saidul Sk of Chhaighari Paschimpara, P.S. Doulatabad, Murshidabad is the same and one person and the rectification in the charge sheet so submitted before the court below was done by the Ld. CJM, Murshidabad vide order dt. 21.08.2018.

Heard. Considered the prayer of the PP in-Charge.

Perused the case record including the charge sheet and the order sheets of the Ld. CJM, Murshidabad and I do find that inadvertent error regarding the identity of the accused Anarul Sk S/o. Saidul Sk has already been rectified by the Court Below itself and it has already been clarified that Anarul Sk S/o. Saidul Sk and Bikash Sk. S/o. Saidul Sk of Chhaighari Paschimpara, P.S. Doulatabad is the same and one person. I also do find that the said accused Anarul Sk S/o. Saidul Sk is filed for present vide order dt. 30.10.2018 passed by Ld. CJM, Murshidabad.

In view of the above, personal appearance of the IO of this case SI Jamaluddin who has retired from the service is dispensed with. The personal appearance of the OC, Doulatabad P.S. is also dispensed with.

Fix 20.12.2024 for consideration of charge against the accused Saidul Sk and Selim Sk.

Ld. PP in-Charge to take steps accordingly.

C/D be produced on the next date fixed.

Accused be present before this court on the date fixed.
