Firstly, that you on 07.11.2023 at 9:30 P.m. at village Hukahara under P.S. Jalangi, Dist. Murshidabad, in furtherance of common intention voluntarily caused hurt to Amina Bewa, Ahasan Mondal and Rakibul Islam and that you all thereby committed an offence punishable under Section 323/34 of I.P.C., and within the cognizance of this Court.

Secondly, that you on the aforesaid date, time and place, you, in furtherance of common intention assaulted Amina Bewa and outraged her female modesty and that you thereby committed an offence punishable under Section 354/34 of I.P.C., and within the cognizance of this Court.

Thirdly, that you on the aforesaid date, time and place, you in furtherance of common intention did commit murder by intentionally causing the death of Rakibul Islam with bamboo stick on his head and thereby committed an offence punishable under section 302/34 of the IPC, and within the cognizance of this Court.

And I hereby direct that you be tried on the said charge.
