CHARGES WITH FOUR HEADS
[NO.XXVII(II) SCHEDULE V, ACT V, 1898]
(Sections 221,222,223, Code of Criminal Procedure)

I, Shri Ajay Kumar Singh
Additional Sessions Judge,
3rd Court, Murshidabad
Berhampore, West Bengal.
hereby charge you –

**1) Tajmul Sk @Tajimul Sk @ Tajimul 2) Sakirul Islam
and 3) Selina Bibi** as follows:-

Firstly, that you- on 20.11.2019 at 10:00 hrs. at village Gouripur under P.S. Doulatabad, Dist. Murshidabad, in furtherance of common intention committed criminal trespass into the house of Ajad Sk and that you all thereby committed an offence punishable under Section 448/34 of I.P.C., and within the cognizance of this Court.

Secondly, that on the aforesaid date, time and place, you, in furtherance of common intention voluntarily caused grievous hurt to Ajad Sk by assaulting him with fist and blows and that you thereby committed an offence punishable under Section 323/34 of I.P.C., and within the cognizance of this Court.

Thirdly, that on the aforesaid date, time and place, you, in furtherance of common intention voluntarily caused grievous hurt to Ajad Sk by assaulting him with hasua upon his person and that you thereby committed an offence punishable under Section 324/34 of I.P.C., and within the cognizance of this Court.

Fourthly, that you on the said date, time and place, in furtherance of common intention attempted to commit murder of Ajad Sk by assaulting him with hasua upon his person and that you thereby committed an offence punishable under section 307/34 of the Indian Penal Code, and within the cognizance of this Court.

And I hereby direct that you be tried on the said charge.

Substance of the charge of the offence punishable under the aforesaid section so framed against accused persons as mentioned here-in- above is read over and explained to them in Bengali to which they pleaded not guilty and claimed to be tried.
