ORDER.

1. Arguments heard.

2. In the present case after hearing arguments on behalf of Ld. counsel for ***Raman alias Rawan Deep Kaur and Komal Kaur, (applicants/accused)*** and Ld. Addl. Public Prosecutor for the State assisted by Ld. counsel for complainant, the applicants/accused was granted **interim anticipatory bail vide order dated 23.01.2025** and were directed to appear before the investigating agency. Today learned Addl. Public Prosecutor for the State has stated at bar that ***Raman @ Rawan Deep Kaur and Komal Kaur, (applicants/accused)*** have **joined the investigation in this case on 26.01.2025**. *Sub Inspector Nirmal Singh No.147/ Tarn Taran posted at police station Kulgari*, is also present in the court along with police record, who has *suffered* statement that ***Raman alias Rawan Deep Kaur and Komal Kaur, (applicants/accused)*** have **joined the investigation of present case on 26.01.2025** as per **order dated 23.01.2025** and further stated that they are no more required for the purpose of further investigation. He has no objection, if the interim bail order dated 23.01.2025 be made absolute.

3. In view of statements of learned Addl. Public Prosecutor for the State as well as of *Sub Inspector Nirmal Singh No.147/ Tarn Taran posted at police station Kulgari*, who has brought police record and affirmed the fact of joining of investigation by the applicants/accused, coupled with the fact that they are no more required for the purpose of further investigation, **order dated 23.01.2025** vide which interim bail was granted to ***Raman alias Rawan Deep Kaur and Komal Kaur***, (applicants/accused), the same is made absolute, subject to the conditions mentioned therein. Accordingly, bail application is disposed off.

However, these observation of mine shall have no effect on the merits of the case. File be consigned to record room after due compliance.
