

SSI Case No. 347 of 2026

Order No. 16, dated 14.07.2026

Accused Hasibul Mondal, Taha Mondal @ Tahajul Mondal, Khurshed Alam @ Alam @ Khurshid Alam Mondal, Meheub Mondal @ Chatha Meheub Alam Mondal, Hasan Sk, Rejaul Mondal @ Raju, Sajamal Mondal, Jalim Mondal @ Dalim Mandal and Selim Mondal @ Anoar Mondal are produced from J/C.

Seven accused persons, namely, Mamlet Mondal @ Bablu Mondal, Mojibar Mondal @ Khuku, Nur Islam Biswas, Rubel Mondal @ Bachhu, Kutubuddin Biswas, Halim Sk and Jamal Sk @ Jamal Sekh on bail are present.

Today is fixed for consideration of charge, hearing bail applications and verification report by OC Nawda PS.

Ld. Special PP in-charge and learned defence counsels are present.

Seen the report forwarded by OC Nawda PS stating that the identity of the accused persons who surrendered before this court has been verified. Let it be kept with the record.

The record is now taken up for consideration of charge.

Learned PP in-charge opens the case of the prosecution by describing the charge against the accused persons and the evidence to be adduced by prosecution.

Heard learned advocate for the accused.

Perused the charge sheet and documents forwarded herewith and also the case diary.

Considering the facts and circumstances and materials available on record, it prima facie transpires that the accused persons, in furtherance of their common intention, committed trespass, in order to commit offence, in to the house of the complainant, they voluntarily caused hurt to Meheub Mursid and Marium Bibi, they voluntarily caused grievous hurt to Jalaruddin by means of dangerous weapons, they intentionally caused death of Rafikul Mondal. It is further found that the accused persons possessed explosives without any lawful object and they possessed the same with intent to commit offence and they caused explosion endangering life and thereby causing death of Rafikul Mondal.

Thus, a prima facie case u/S 329/118(1)/118(2)/109/103(1) read with section 3(5) of BNS and also under section 3/4/5 of Explosive Substance Act is made out against the accused persons. Charge is accordingly framed against the accused persons which is read over and explained to them in Bengali. Each of the accused persons pleads not guilty to the charge and claims to be tried.

Fix 19.08.2026 for examination of complainant.

20.08.2026 for examination of CSWs-2 & 3,

21.08.2026 for examination of CSWs-4 & 5 and

24.08.2026 for examination of CSWs-6 & 7.

Prosecution to take steps for summoning the witnesses accordingly.

Accused persons as before.

Bail petition filed on behalf of the accused 1. Hasibul Mondal, 2. Taha Mondal @ Tahajul Mondal, 3. Khurshed Alam @ Alam @ Khurshid Alam Mondal, 4. Meheub Mondal @ Chatha Meheub Alam Mondal, 5. Hasan Sk, 6. Rejaul Mondal @ Raju, 7. Sajamal Mondal, 8. Jalim Mondal @ Dalim Mandal and 9. Selim Mondal @ Anoar Mondal are moved.

Learned advocates for the accused persons submit that some of the accused persons are on bail and these accused persons are on the same footing. Learned advocate for accused Hasibul Mondal submits that Hasibul Mondal is in custody since 02.07.2025. Learned advocate submits that accused are local persons and there is no chance of absconsion. The learned advocates also submit that there is no chance of tampering of the evidence or inducing the witnesses. They pray for granting bail to the accused persons on any condition.

Learned Special PP strongly opposes the bail prayer. He submits that the accused persons have committed heinous offence and specially Hasibul Mondal and Taha Mondal @ Tahajul Mondal were the masters in the commission of the offence. He further submits that on being released on bail the accused persons may try to induce or threat the witnesses.

Perused the case record and the CD.

Having considered the materials appearing on record in the form of statements of witnesses recorded under sections 180 and 183 of BNSS, injury report, PM reports and the results of forensic examination and keeping in mind that some of the accused persons are already on bail, I am inclined to grant bail to the accused persons excepting the accused Hasibul Mondal and Taha Mondal @ Tahajul Mondal who happen to be the principal accused persons so far as the causing of explosion is concerned which resulted in death of Rafikul Mondal.

Thus bail petitions of accused Hasibul Mondal and Taha Mondal @ Tahajul Mondal are rejected and that of the rest accused persons in J/C are allowed.

Accused 1. Khurshed Alam @ Alam @ Khurshid Alam Mondal, 2. Meheub Mondal @ Chatha Meheub Alam Mondal, 3. Hasan Sk, 4. Rejaul Mondal @ Raju, 5. Sajamal Mondal, 6. Jalim Mondal @ Dalim Mandal and 7. Selim Mondal @ Anoar Mondal may find a bail of Rs.15000/- each with two sureties of Rs.7500/- each, one of whom must be local having landed property within the jurisdiction of this court, to the satisfaction of learned CJM, Murshidabad.

On being released on bail, the accused persons shall attend court on each and every date or they shall not induce, threat, intimidate or allure the witnesses of this case in any manner whatsoever.

To date for appearance and production and evidence by prosecution as scheduled.

Copy of this order be sent to the learned CJM, Murshidabad for information and taking necessary action.
