It has been submitted by the learned Lawyer for the accused/petitioner that W/A was issued against this accused petitioner on 28.04.2023 as he could not attend the Court and considering the voluntariness, he prays for bail.

Learned Public Prosecutor leaves the matter to the discretion of this Court.

Having heard learned Lawyers of the respective parties and having considered the materials on record and taking into consideration that the accused person was previously on bail and he has voluntarily surrendered before this Court, I am inclined to allow the prayer for bail.

Accordingly, accused Mohidul Mondal @ Maidul Islam @ Sahidul Mondal may find bail of Rs. 5,000/- with two sureties of Rs. 2,500/- each, other than previous sureties, subject to satisfaction of Ld. CJM, Murshidabad.
