

State vs. Chamkaur Singh etc. 119.20 CHI

Present:- Sh.Iqbal Singh, learned APP for the State.
None for both the accused namely Chamkaur Singh and Joginder Singh.

ASI Dilbag Singh vide his separately recorded statement stated that on dated 22.12.2024 he received the proclamation of accused Chamkaur Singh son of Balkar Singh R/o Singhariwala Patti now Assal Patti and on 22.12.2024, he visited the above said address of the accused but the accused did not met as house of accused was locked and then he got recorded the statement of Charanjit Singh Numberdar and read over all the contents to him and on admitting correct, he thumb marked on his statement Ex.PB, thereafter he affixed the copy of the proclamation outside of the house of accused, one copy was affixed in the common place of village and announcement was made through Gurudwara Sahib and one copy was affixed outside the notice board of this Court. In this regard he has proved proclamation Ex. PA, Statement Ex. PB and his report Ex.PC.

ASI Dilbag Singh vide his separately recorded statement stated that on dated 22.12.2024 he received the proclamation of accused Joginder Singh son of Hazara Singh R/o Ward No.1 Single Basti Patti and on 22.12.2024, he visited the above said address of the accused but the accused did not met as house of accused was locked and then he got recorded the statement of Karamjit Kaur M.C and read over all the contents to her and on admitting correct, she thumb marked on her statement Ex.PE, thereafter he affixed the copy of the proclamation outside of the house of accused, one copy was affixed in the common place of village and announcement was made through Gurudwara Sahib and one copy was affixed outside the notice board of this Court. In this regard he has proved proclamation Ex. PD, Statement Ex. PE and his report Ex.PF.

After considering the statement of serving official ASI Dilbag Singh I am satisfied that proclamation was duly published against both the accused on 22.12.2024 as per law and rules and as both the accused have not appeared after expiry of 30 days from the publication of proclamation, therefore both the accused Chamkaur Singh and Joginder Singh are declared as proclaimed person. Intimation be sent to the concerned police station.

As the accused have been declared proclaimed person and they have absconded and there is no immediate prospect for arresting them, therefore, the present case is to be fixed for recording evidence under Section 299 of Cr.P.C. and prosecution is also directed to furnish list of property of accused for proceedings under Section 83 Cr.P.C.

Now, to come up on 08.04.2025 for evidence under Section 299 of Cr.P.C. and notice to witnesses mentioned at serial No.1 to 5 be issued for date fixed. List of property of accused be also filed for date fixed.
