Order : Case against the accused is committed to the Hon'ble Court of
Sessions, Ernakulam.

ORDER

1. The accused stand charge sheeted by the Sub Inspector of Police Ramamangalam Police Station in crime No: 208/25 of the Ramamangalam Police Station for the offences alleged to have been committed by him punishable under sections 77, 2 BNS.
2. The Prosecution case: With the intention and knowledge of causing mental distress to the defacto complainant, the accused took photographs and videos of the defacto complainant using the mobile phone belonging to and used by him, under the pretext that the same were required for uploading on the FaceApp application. Thereafter, on 22.03.2025 and on dates prior thereto, the accused forwarded the said photographs and videos to the husband of the defacto complainant, who was living separately from her. By such acts, the accused intentionally caused mental anguish and harassment to the defacto complainant and thereby committed the punishable offence alleged against

him.

3. After filing the final report process was issued to the accused. On appearance of the accused, bail was granted to him and the copies of the documents relied on by the prosecution were given to the accused under section 230 of BNSS. The accused is represented by a counsel of his own choice.
4. Heard both sides. I find a prima facie case for the offences punishable under sections 77, 2 BNS, which are the offences exclusively triable by the Hon'ble Court of Sessions. Hence the case against the accused is committed to the Hon'ble Court of Sessions, Ernakulam under section 232(a) of BNSS.
5. The accused, who is on bail is directed to appear before the Hon'ble court of Sessions, Ernakulam as and when directed.
6. The records of this case will be submitted to the Hon'ble Court of Sessions, Ernakulam.
7. The committal of the case will be notified to the Public Prosecutor, Ernakulam under section 232(d) of BNSS.
8. The thondi articles/ properties will be produced before the Hon'ble Court of Sessions, Ernakulam as and when directed.
