ORDER BELOW EXH.

The accused has voluntarily pleaded guilty when asked to him in vernacular. It appears that the accused voluntarily pleaded guilty. The accused is alleged to have committed the offence punishable under section 8 (5), 24 of the I.P.C / BNS, 2023 / MV Act / NDPS Act / COFT Act / Maharashtra Police Act. Thus, he will have to be convicted. Hence, I proceed to hear him on the point of sentence.

2. Heard the accused on the point of sentence. He submitted that he is the only earning member in his family. His economic condition is not sound. His family is totally dependent on his income. He further stated that it is his first offence and he assured that he will not commit any offence in future. Lastly, he prayed for minimum sentence by taking lenient view. There is no evidence on record of previous conviction of the accused under the said section/s. In view of nature of offence and legal provision, following order will meet the end of justice. Therefore, I pass the following order:-

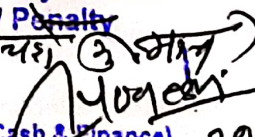
ORDER

- 1) The accused Vishal Dinkar Rane is convicted under Section 275 of the Bharatiya Nagarik Suraksha Sanhita, 2023 for the offence punishable under section 8 (5), 24. of the I.P.C / BNS, 2023 / MV Act / NDPS Act / COFT Act / Maharashtra Police Act and he is sentenced to pay fine of Rs. 500/- (Rs. Rupees only), in default of payment of fine he shall suffer simple imprisonment for 07 days.
- 2) Worthless muddemal, if any be destroyed and Valuable Muddemal, if any be return to the owner as per rules.
